# Representations received from members of the public

Prior to the meeting, Michael Richardson from Good News Everyone (formerly Gideons UK) presented the Mayor with a bible for the Town Council and offered all councillors a copy of New Testament Psalms & Proverbs. The Mayor thanked him for the gifts.

Cllr Richard Streatfeild, Sevenoaks District Council & Kent County Council (KCC), gave an update on key matters:

- KCC budget consultation 2026-27 was in process
- £50m savings needed to be found in year
- Regarding Local Government Organisation, KCC Reform UK had put forward a single unitary council for Kent and Medway proposal, whilst the opposition view favoured a three unitary model
- Sevenoaks Primary School had to delay the return to school for Years 3 to 5, following vandalism of a generator and theft of cabling, KCC was working closely with the Headteacher & Trustees to reopen for all pupils
- No update yet available on East West Cycle Route, which was scheduled to finish in the Autumn

# 292 - LOCAL GOVERNMENT REVIEW - SEVENOAKS DISTRICT COUNCIL COMMUNITY ASSET TRANSFER PROCESS

Within the Local Government Review, the Town Council submitted six Expressions of Interest to Sevenoaks District Council (SDC) for Tranche 1 of the Community Asset Transfer programme:

- 1. Stag Community Arts Centre
- 2. Hollybush Recreation Ground
- 3. Land at Bradbourne Vale Road Horses field

- 4. Land at High Street / Market Rights
- 5. St John's Hill Car Park
- 6. St James Road Car Park

All but the Stag had received 'guidance from SDC' not to pursue but SDC also advised that Town and Parish Councils could continue along the process at their 'own risk'.

Consideration of the transfer of the Stag was to be considered at SDC's Finance & Investment Advisory Committee on 2<sup>nd</sup> September 2025, with the report recommendation proposing a 100-year lease for the Stag on a peppercorn rent to Sevenoaks Town Council.

Sevenoaks Town Council (STC) had several concerns with taking on a 100-year lease rather than the Freehold of the Stag. The proposal could provide financial disadvantages to the Town Council, and ultimately the Stag charity, for the following reasons:

- current proposals for future significant investment in the Stag would need permission from the new Unitary Authority, as would loans or entering into longterm agreements
- the lease arrangement would likely include regular rent reviews, and the new Unitary Authority could decide to demand a rent that made the Stag unviable operationally
- the proposed lease excluded the current car parking area which was vital for staff, volunteers and show 'load-ins' which often involve large trucks

The SDC report also stated that the Stag could be sold on the open market for £1.5m, however, this is not the case. STC still has a 10-year lease and there are many planning restrictions. An independent professional valuation had provided a current market value of £400k - £750k. Since 2009, when STC took over the Stag with the charity it has enabled £1.5m capital investment via grants etc. into the building. If there were concerns that STC might sell the building in the future, an overage (payment for development) could be applied to the Freehold.

Sevenoaks Town Council hopes the District Council will reconsider and transfer the Freehold of the Stag, ensuring the community retains this cultural facility, enabling continued investment for future generations, and avoiding any opportunity for it to be considered for development.

The Town Council is also at this stage continuing to progress requests for Community Asset Transfers by completing a Business Proposal for Hollybush Recreation Ground, Land at Bradbourne Vale Road (Horses Field) and Land at High Street (Market Rights). These are expected to be considered in Tranche 2.

SDC are inviting further Expression of Interest submissions for Community Asset Transfers for Tranche 2 by 12<sup>th</sup> September.

The Town Council's ongoing consultation with residents in the form of a survey asking which community assets should be requested, revealed that as of 26<sup>th</sup> August the top six were: Stag Theatre & Cinema, Hollybush Recreation Ground, Land at High Street – Market Rights, Bradbourne Lakes, Land at Bradbourne Vale (Horses Field) and The Shambles.

Council received and noted a letter from Bradbourne Residents' Association expressing reservations about the transfer of Bradbourne Lakes to the Town Council due to potential impact on the renovation project, Bradbourne Re-Bourne, and the District Council's commitments to the Heritage Lottery Fund (HLF), including the 10-year management Plan. Due to the lack of firm details at this stage the Residents' Association did not feel able to support the transfer of Bradbourne Lakes to the Town Council at this time.

It is very unfortunate that the timing of the progressing of the Bradbourne Lakes HLF Funding coincides with the Local Government Review. The timing of this could be crucial to delivery and bearing in mind the Ministry of Housing, Communities and Local Government guidance issued in July 2025 about potential financial commitments for the new Unitary Authority. The new shadow and ultimately Unitary Authority may not want to take on such commitments.

Sevenoaks Town Council would be submitting an Expression of Interest for the Community Asset Transfer as an additional "safety net" in case there is a need for a different "successor Council" at the time of the HLF decision in relation to Local Government Review.

Discussion took place about The Shambles and how this cultural area could be maintained by the Town Council.

# **RESOLVED** that Sevenoaks Town Council:

- 1) strongly confirms its preference for the transfer of the Freehold of the Stag rather than a lease
- 2) submits Expressions of Interest for Bradbourne Lakes and The Shambles in SDC Tranche 2
- 3) continues to review appropriate assets which should be transferred to the local council noting that these negotiations may need to be required to take place with the new shadow Unitary Council.

# 293 - SEVENOAKS LAWN TENNIS CLUB, LAND REGISTRY DOCUMENT
